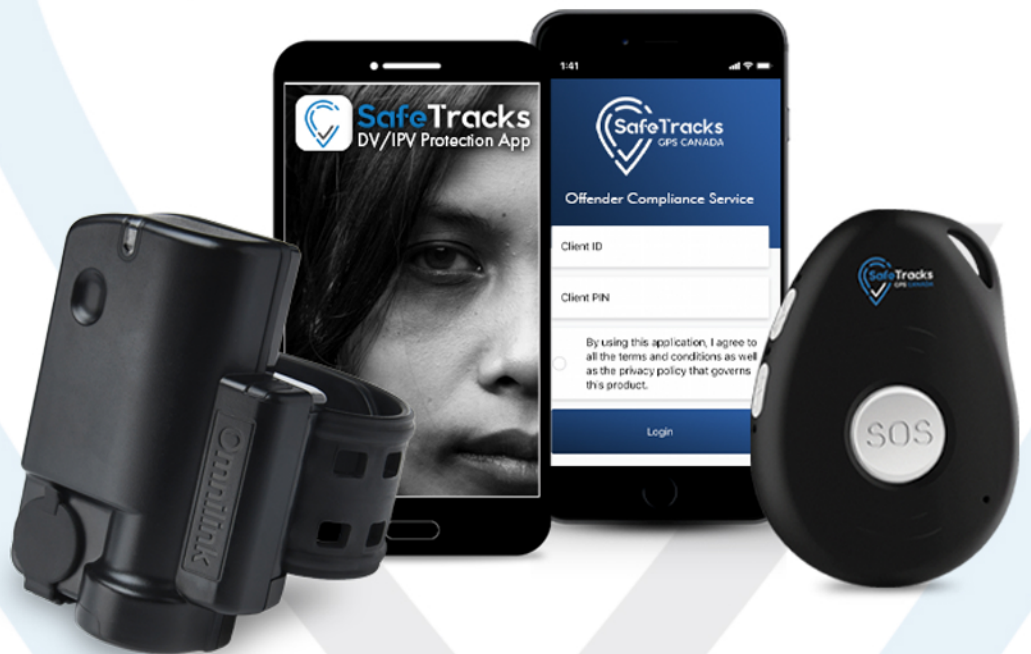

Surety & Guarantor Cooperation Agreement

SAFETRACKS GPS CANADA INC. ("SAFETRACKS")

By signing below, I hereby acknowledge that I have read and fully understand the contents of this document in its entirety, and I voluntarily agree to fully cooperate with SAFETRACKS GPS in all respects. My obligations shall include, but are not limited to:

- Assisting SAFETRACKS in ensuring the Participant's compliance with all program requirements;
- Will ensure that the participant's account is in good standing and all monies owed are paid in full. I will not dispute any charges associated with SAFETRACKS.
- Providing updated contact information and responding to all telephone calls from SAFETRACKS and providing immediate replies to any telephone calls, or email communications received from SAFETRACKS;
- In the event that the Participant is residing with me or is otherwise present in my home, permitting SAFETRACKS staff and or its agent to enter my residence at any time, whether for scheduled or unscheduled testing, inspection, or maintenance of SAFETRACKS equipment.

I understand that my cooperation as outlined above is essential to the effective operation of SAFETRACKS's program, and I agree to comply fully with all obligations stated herein.

I, the undersigned, acknowledge and agree that as Surety and/or Guarantor for the above-named Participant, I am legally bound and obligated to assume full responsibility for any and all outstanding invoices owed to SAFETRACKS in the event the Participant fails to fulfill their financial obligations and maintain their account in good standing. Such obligations may include, but are not limited to:

- Unpaid Invoices including Monthly Service Fees (MSF);
- Unpaid invoices for extra parts such as device chargers
- Costs associated with damaged or lost equipment.

By affixing my signature below, I expressly agree to be held liable for the payment of any and all amounts due, including any additional fees or costs incurred as a result of the Participant's delinquency.

I understand that if SAFETRACKS, in its absolute discretion, is not satisfied with the cooperation it receives from me or the participant, SAFETRACKS may terminate its services to the Participant.

I understand that as a Surety and/or Guarantor to the above name Participant, I must Adhere to the SAFETRACKS's "Leave Notification Procedures", as well as any customized or revised procedures that SAFETRACKS may implement from time to time.

Leave Notification Procedure:

- **ADVANCE NOTICE FOR SPECIFIED PURPOSES:** When your court order says that you are permitted to leave your residence only for specific purposes, you must follow SAFETRACKS Procedures and send in the required permission letter or documents, that would be provided by the assigned probation or parole officer.
- When leaving your residence with the participant, and you are the court approved surety, You **MUST** email privaterentals@safetracksgps.ca, from your (the surety) personal email address, during business days and hours (Monday-Friday, 8:00am-5:00pm MST) with at least **ONE hour** prior to requested departure time, to leave the court ordered residence, with the Participant.
- In your request to leave with the participant, your email must include the following information:
 - Participant's Name
 - Surety and/or Guarantor Name and contact information
 - Date you want to leave
 - Time you want to leave
 - Time you will return

I authorize SAFETRACKS GPS to record all telephone calls or other communications between me and SAFETRACKS GPS. I authorize SAFETRACKS, at any time, to provide any information and records about me or provided by me, including the contents of all communication between me and SAFETRACKS GPS, to legal authorities, crown prosecutor and court officials.
